

PUBLIC NOTICE FOR THE ATTRIBUTION OF A RESEARCH GRANT (BI), FOR A BACHELOR'S DEGREE HOLDER, UNDER THE PROJECT "HABITAÇÃO, BEMESTAR E DESIGUALDADES NO SUL DA EUROPA: ESTUDO EXPLORATÓRIO DE PORTUGAL SOBRE A GERAÇÃO Z", PROJECT 2022.04292.PTCD, TO BE DEVELOPED IN THE CENTRE FOR PUBLIC ADMINISTRATION AND PUBLIC POLICIES (CAPP) OF THE INSTITUTE FOR SOCIAL AND POLITICAL SCIENCES OF THE UNIVERSITY OF LISBON (ISCSP-ULISBOA)

It is available an application for the attribution of one (1) Research Grant (BI), for a bachelor's degree holder, from April 24<sup>th</sup> to May 9<sup>th</sup> of 2023, under the project "Habitação, Bem-Estar e Desigualdades no Sul da Europa: Estudo Exploratório de Portugal sobre a Geração Z", 2022.04292.PTCD, to be developed in the Centre for Public Administration and Public Policies (CAPP) of the Institute for Social and Political Sciences of the University of Lisbon (ISCSP-ULisboa).

### **Scientific Area:**

Social Sciences.

### Admission requirements (cumulative):

- Bachelor's Degree in the area of Social Sciences;
- Frequency of a Master's degree in any scientific area;
- Experience with SPSS;
- Experience in participating in research work within the academic formation or others.

### Working plan:

- Prepare and collaborate in the development of research reports, preparation of scientific dissemination processes (articles), and dissemination of research to specific audiences;
- Collect, process and analyse quantitative data from the last Census related to housing arrangements and compare it with the previous 2010 Census, in order to discuss the main intergenerational differences;
- Process and analyze EU-SILC (ICOR) data to obtain an insight into the evolution of the type of housing arrangements in the last two decades in Portugal, as well as to investigate the change in housing deprivation indicators, such as the financial burden of housing costs;
- Explore the main housing trajectories of each generation and the intergenerational transfers;
- Support the collection and analysis of data from deliberative groups, interviews, and focus groups;
- Support the organization of workshops, conferences, and website management.

# Workplace:

The activities will be developed in CAPP of ISCSP-ULisboa, under the scientific supervision of Professor Romana do Carmo Lança Xerez.

### **Grant duration:**

The grant will have the duration of 18 months, expected to start on July 1<sup>st</sup> of 2023, and may be renewed under the terms foreseen in Regulation of Research Grants of FCT an University of Lisbon. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

## **Monthly Maintenance Allowance:**

The amount of the monthly maintenance allowance corresponds to  $\in$  930.98, according to the current table of values of grants awarded directly by FCT, I.P. (<a href="www.fct.pt/apoios/bolsas/valores">www.fct.pt/apoios/bolsas/valores</a>). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law no 40/89, of February 1st, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

## **Selection Methods:**

Applicants will be ranked on a scale from 0 to 20 values.

The selection of candidates will be based on the Curricular Evaluation (60%) and the Interview (40%).

1. The curricular evaluation will be weighed as follows:



- a) Experience of participation in research work within the scope of academic training or or others, including quantitative data analysis and elaboration of research reports and/or other forms of dissemination of results (20%);
- b) Academic training or equivalent in the field of research methods and techniques, quantitative data and preparation of research reports and/or other forms of results dissemination (15%);
- c) Knowledge or practice in collecting, processing, and analysing quantitative data provided by INE, BdP, Eurostat, and OECD (10%);
- d) Proven proficiency in English (10%);
- e) Website content management (5%).
- 2. The <u>interview</u> will be weighed as follows:
  - a) Experience and interest in research in social policy field and housing policies (10%);
  - b) Experience of the data available from the leading producers of relevant statistics, namely INE, Banco de Portugal, Eurostat, and OECD, among others, in the area of housing, housing deprivation, and young people's access to housing (5%);
  - Knowledge from the user's perspective of the software necessary for data analysis, namely SPSS (15%);
  - d) Proficiency in English language (5%);
  - e) Knowledge and interest in organizing scientific events (5%).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, gender image or identity, sexual orientation, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, religion, political or ideological convictions and union trade membership.

## **Notification Process of Results:**

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP-ULisboa. The approved candidate will be notified by email.

The application is available from April 24<sup>th</sup> to May 9<sup>th</sup> of 2023.

# **Application presentation:**

The applications must be formalized, mandatorily, accompanied by the following documents:

- a) Application letter with the identification of the candidate and procedure to which it relates;
- b) Documents proving that the candidate meets the admission requirements, namely a copy of the qualification certificate of the Bachelor's degree, with final average obtained;
- c) Detailed Curriculum Vitae;
- d) Document proving enrolment in the master's degree;
- e) Declaration under oath that there is no professional or service provision activity that violates the duty of exclusive dedication;
- f) Copy of the civil identification document and, whenever applicable, copy of the proof of residence permit or other legally equivalent document;
- g) Motivation letter;
- h) Documents proving proficiency in English language;
- i) Documents supporting the factors that integrate curricular evaluation criteria;
- j) Other supporting documents considered relevant for the application process.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of August 16<sup>th</sup>, and Ordinance n.º 33/2019, of January 25<sup>th</sup>. The presentation of the certificate is mandatory for the signing of the contract.
