

It is available an application for the attribution of 1 (one) Research Grant (BI), for a bachelor's degree holder, from July 26 to August 8, 2022, within the activities developed in the interdisciplinary Centre for Gender Studies (CIEG) of the Institute for Social and Political Sciences (ISCSP) of the University of Lisbon (ULisboa).

Scientific Area:

Social and Political Sciences

Admission requirements (cumulative)

- Degree in Social and Political Sciences
- Frequency of non-degree Course in the area of Gender Equality
- Proven experience in the area of Gender, Feminist and Women Studies
- Proven knowledge of written and spoken English.

According to the article 4 of the Regulation of Research Grants of the Fundação para a Ciência e a Tecnologia (FCT, I.P.), the working plan includes the following tasks:

- Support in carrying out science management activities at CIEG/ISCSP-ULisboa;
- Support in activities related to projects developed by CIEG/ISCSP-ULisboa;
- Support in writing articles and other outputs;
- Support in activities to disseminate knowledge, namely through the construction of scientific dissemination materials;
- Support in the organization of national and international scientific events.

Legislation and regulations:

Research Fellowship Statute, approved by Law n.º 40/2004, of 18 August, in its current wording, amended by Decree-Law n.º 123/2019, of 28 August.

Workplace:

The activities will be developed in CIEG/ISCSP-ULisboa, under the scientific supervision of Professor Anália Torres.

Grant duration:

The grant will have the duration of 12 months, starting on October 1, 2022. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

Monthly Maintenance Allowance:

The amount of the monthly maintenance allowance corresponds to € 875,98, according to the current table of values of grants awarded directly by FCT, I.P. (www.fct.pt/apoios/bolsas/valores). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law n.º 40/89, of February 1st, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

Selection Methods:

The selection of candidates will be based on the curricular evaluation (50%) and the interview (50%).

1. The curricular evaluation (50%) will be weighed as follows:
 - a) Final grade of the degree (25%);
 - b) Proven knowledge of the English language (25%).
2. Interview (50%)
 - a) Suitability of the candidate's profile (25%);
 - b) Interest and knowledge about the area of Gender, Feminist and Women's Studies (25%).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, sex, sexual orientation, gender image or identity, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, language, religion, political or ideological convictions and union trade membership.

Notification Process:

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP. The approved candidate will be notified by email.

Application date:

The application is available from July 26 to August 8, 2022.

Application presentation:

The applications must be formalized, **mandatorily**, by sending a letter of application with the identification of the procedure to which it relates, accompanied by the following documents:

- a) *Curriculum Vitae*;
- b) Certificate of qualifications;
- c) Declaration of enrolment in non-degree Course;
- d) Documents certifying that the admission requirements are fulfilled;
- e) Other supporting documents considered relevant towards the application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of 16 August, and Ordinance n.º 33/2019, of 25 January.
