

PUBLIC NOTICE FOR THE ATTRIBUTION OF A RESEARCH GRANT (BI), FOR A MASTER'S DEGREE HOLDER, UNDER THE PROJECT "PUBLIC FISCAL GOVERNANCE IN THE POST COVID-19 AND DIGITAL ERA", UNIT UIDB/00713/2020, TO BE DEVELOPED IN THE CENTRE FOR PUBLIC ADMINISTRATION AND PUBLIC POLICIES (CAPP) OF THE INSTITUTE FOR SOCIAL AND POLITICAL SCIENCES OF THE UNIVERSITY OF LISBON (ISCSP-ULISBOA)

It is available an application for the attribution of one (1) Research Grant (BI), for a master's degree holder, from November 28th to December 13th of 2022, under the project "*Public Fiscal Governance in the Post Covid-19 and Digital Era*", Unit UIDB/00713/2020, to be developed in the Centre for Public Administration and Public Policies (CAPP) of the Institute for Social and Political Sciences of the University of Lisbon (ISCSP-ULisboa).

Scientific Area:

Public Administration, Political Science, or similar

Admission requirements (cumulative):

- Master's Degree;
- Frequency of a PhD degree in Public Administration, Political Science, Sociology, Social Policy, or International Relations;
- Proficient in Portuguese and English language.

Working plan:

- Conducting bibliographical and documental research and its organization;
- Collecting and processing the database (documentary collection and empirical data);
- Support for the preparation of presentation and writing of first results, and revision of scientific texts for publication purposes;
- Conducting research work and presenting outputs under the scope of the project;
- Development of project management support activities.

Legislation and regulations:

Research Fellowship Statute, approved by Law n.º 40/2004, of 18th August, in its current wording, amended by Decree-Law n.º 123/2019, of 28th August.

Regulation of Research Grants of the Fundação para a Ciência e a Tecnologia (FCT, I.P.), in force, approved by Regulation No. 950/2019, of 16th December https://www.fct.pt/apoios/bolsas/regulamento.phtml.pt or as published in DRE: https://dre.pt/application/file/a/127230968.

Workplace:

The activities will be developed in CAPP of ISCSP-ULisboa, under the scientific supervision of Professor José Roberto Rodrigues Afonso.

Grant Duration:

The grant will have the duration of 10 months, expected to start on February 1st of 2023, and may be renewed under the terms foreseen in Regulation of Research Grants of FCT. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

Montly Maintenance Allowance:

The amount of the monthly maintenance allowance corresponds to € 1 144.64, according to the current table of values of grants awarded directly by FCT, I.P. (www.fct.pt/apoios/bolsas/valores). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law nº 40/89, of February 1st, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

Selection Methods:

Applicants will be ranked on a scale from 0 to 100 points.

The selection of candidates will be based on the curricular evaluation (50%) and the interview (50%).

- 1. The curricular evaluation will be weighed as follows:
 - a) Knowledge of quantitative data processing and analysis programs (10%);
 - b) Professional experience in public administration (10%);
 - c) Knowledge of research methodology and scientific writing rules (10%);
 - d) Experience with conducting interviews and their de-recording and analysis (5%);

- e) Previous participation and experience of integration in research project teams (5%);
- f) Knowledge area and grade obtained in the master's degree (5%);
- g) Proficiency in Portuguese and English languages (5%).
- 2. The Interview will be weighed as follows:
 - a) Academic background and/or professional experience with the subject of public governance (15%);
 - b) Predisposition to carry out research work (15%);
 - c) Motivation for obtaining the grant (10%);
 - d) Communication and interpersonal relationship skills (10%).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, gender image or identity, sexual orientation, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, religion, political or ideological convictions and union trade membership.

Notification Process of Results:

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP-ULisboa. The approved candidate will be notified by email.

Application date:

The application is available from November 28th to December 13th of 2022.

Application presentation:

The applications must be formalized, mandatorily, accompanied by the following documents:

- a) Application containing the identification of the candidate and of the procedure;
- b) Documents proving that it meets the required conditions, namely certificates of qualifications of Bachelor's and Master's academic degrees, with final average obtained;
- c) Declaration of enrolment in the PhD degree;
- d) Curriculum Vitae;
- e) Copy of the civil identification document and, whenever applicable, copy of the proof of residence permit or other legally equivalent document;
- f) Documents supporting the training obtained in the areas of curricular evaluation;
- g) Other supporting documents considered relevant towards the application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of 16th August, and Ordinance n.º 33/2019, of 25th January, in its current wording.
