

**PUBLIC NOTICE FOR THE ATTRIBUTION OF A POST-DOCTORAL RESEARCH GRANT (BIPD), FOR A DOCTOR'S DEGREE HOLDER, UNDER THE ACTIVITIES DEVELOPED IN THE INTERDISCIPLINARY CENTRE FOR GENDER STUDIES (CIEG) OF THE INSTITUTE FOR SOCIAL AND POLITICAL SCIENCES OF THE UNIVERSITY OF LISBON (ISCSP-ULISBOA)**

It is available an application for the attribution of one (1) Post-Doctoral Research Grant (BIPD), for a doctor's degree holder, from November 28<sup>th</sup> to December 13<sup>th</sup> of 2022, under the activities developed in the Centre for Interdisciplinary Centre for Gender Studies (CIEG) of the Institute for Social and Political Sciences of the University of Lisbon (ISCSP-ULisboa).

**Scientific Area:**

Sociology

**Admission requirements (cumulative):**

- PhD Degree in Sociology;
- Proven research experience in the area of Gender Studies;
- In compliance with the provisions of Article 7 of Regulation No. 950/2019, of 16<sup>th</sup> December:
  - a) Have a Doctoral degree obtained within the three years prior to the date of submission of the application for the research grant;
  - b) Have carried out the research leading to the award of the PhD degree in an entity other than the host unit (CIEG of ISCSP-ULisboa);
  - c) Do not exceed, with the conclusion of the contract in question, including possible renewals, an accumulated period of three years in this type of research grant, consecutive or interpolated.

**Preferential evaluation requirements:**

- Participation in international research projects;
- Experience in research in the area of sexuality.

**Working plan:**

- Development of research activities within CIEG's strategic plan, namely on the topics of harassment, masculinities and sexuality;
- Annual submission of at least one international publication on a peer-reviewed specialized journal;
- Participation in CIEG's editorial projects;
- Collaborating in the elaboration of CIEG's submissions to national and international funding programmes;
- Collaborating in the development of CIEG's activities related to communication of science, as a way to transfer the research developed.

**Legislation and regulations:**

Research Fellowship Statute, approved by Law n.º 40/2004, of 18<sup>th</sup> August, in its current wording, amended by Decree-Law n.º 123/2019, of 28<sup>th</sup> August.

**Workplace:**

The activities will be developed in CIEG of ISCSP-ULisboa, under the scientific supervision of Professor Anália Maria Cardoso Torres.

**Grant duration:**

The grant will have the duration of 12 months, expected to start on March 1<sup>st</sup> of 2023, and may be renewed under the terms foreseen in Regulation of Research Grants of FCT. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

**Monthly Maintenance Allowance:**

The amount of the monthly maintenance allowance corresponds to € 1 686.00, according to the current table of values of grants awarded directly by FCT, I.P. ([www.fct.pt/apoios/bolsas/valores](http://www.fct.pt/apoios/bolsas/valores)). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law n.º 40/89, of February 1<sup>st</sup>, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

**Selection Methods:**

Applicants will be ranked on a scale from 0 to 20 values.

The selection methods will be weighed as follows:

1. Curricular evaluation (0 – 6 values):
  - a) Academic qualifications (0 – 3 values);
  - b) Academic career (0 – 3 values).
2. Work plan (0 – 8 values).
3. Interview (0 – 6 values).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, gender image or identity, sexual orientation, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, religion, political or ideological convictions and union trade membership.

**Notification Process of Results:**

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP-ULisboa. The approved candidate will be notified by email.

**Application date:**

The application is available from November 28<sup>th</sup> to December 13<sup>th</sup> of 2022.

**Application presentation:**

The applications must be formalized, **mandatorily**, by sending a letter of application with the identification of the procedure to which it relates, accompanied by the following documents:

- a) *Curriculum Vitae*;
- b) Certificate of qualifications;
- c) One scientific publication exemplifying the candidate's merit;
- d) Work plan proposal (maximum of 3000 words);
- e) Documents certifying that the admission requirements are fulfilled;
- f) Other supporting documents considered relevant towards the application.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of 16<sup>th</sup> August, and Ordinance n.º 33/2019, of 25<sup>th</sup> January. Failure to submit the documents referred to in paragraphs a) to e) automatically determines the non-admission to the procedure.
