Introduction

In 2022, the research carried out at ISCSP obtained results of the utmost importance. These include the contribution of the three research centres, two rated Excellent by FCT - the Centre for Administration and Public Policy (CAPP) and the Interdisciplinary Centre for Gender Studies (CIEG), and one rated Good - the Orient Institute (IO). These results were achieved during a period that was still heavily affected by the COVID-19 pandemic, which had great impact on scientific activities.

Of the numerous activities carried out, we highlight the publications, particularly in international book chapters, which increased by 79% compared to 2021. Articles in international journals grew by 15%, namely articles indexed in WoS, with an increase of 24%, and articles indexed in SCOPUS, with an increase of 17%. A solid growth was also seen in the most relevant articles - SCOPUS Q1, with an increase of 26%, and WoS Q1, with an increase of 8%. Communications at national scientific meetings increased by 79%. The number of research projects was also the highest ever, with 27 projects funded by national and international institutions. Also noteworthy was

the remarkable momentum in the development of new research project proposals: 33 new research project applications were submitted, representing around 3 million euros.

The growth and strengthening of research activities has contributed to an increase in high-quality scientific production, reflected in internationalisation and social impact. The link between research and society, through contributions towards public policies, the dissemination of scientific production to academic and non-academic audiences, in the media, in interviews, opinion articles and references to projects, have all contributed to the growth of the scientific dissemination.

Sustainability issues, particularly the Sustainable Development Goals (SDGs), were widely examined, and numerous papers were published in this area in leading books and journals. Also noteworthy is a stronger link between research and teaching, through the increase in Master's dissertations, PhD theses and post-doctoral studies.

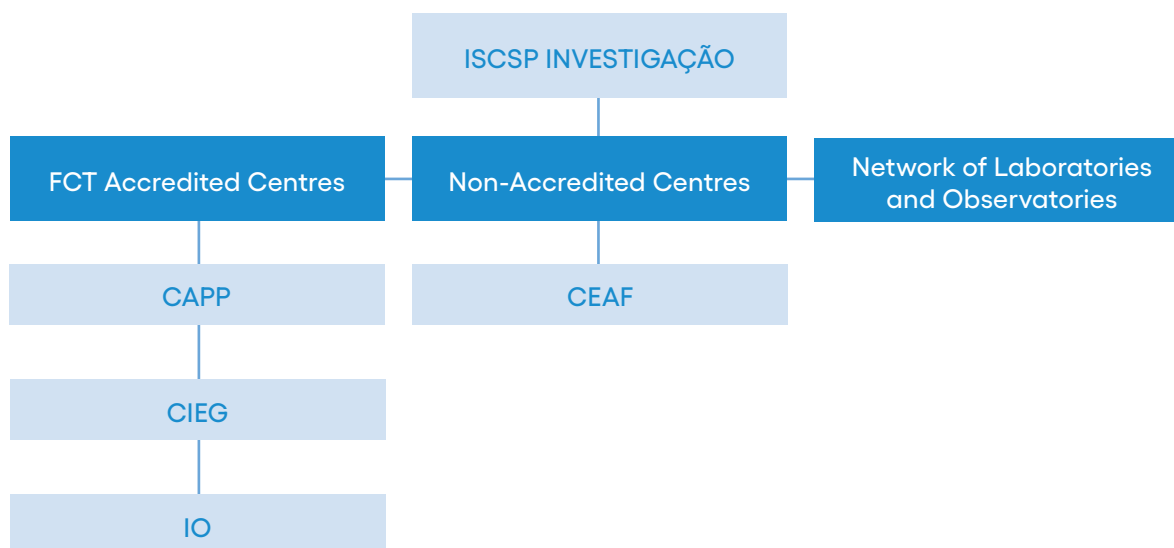
The Research Support Centre is responsible for:

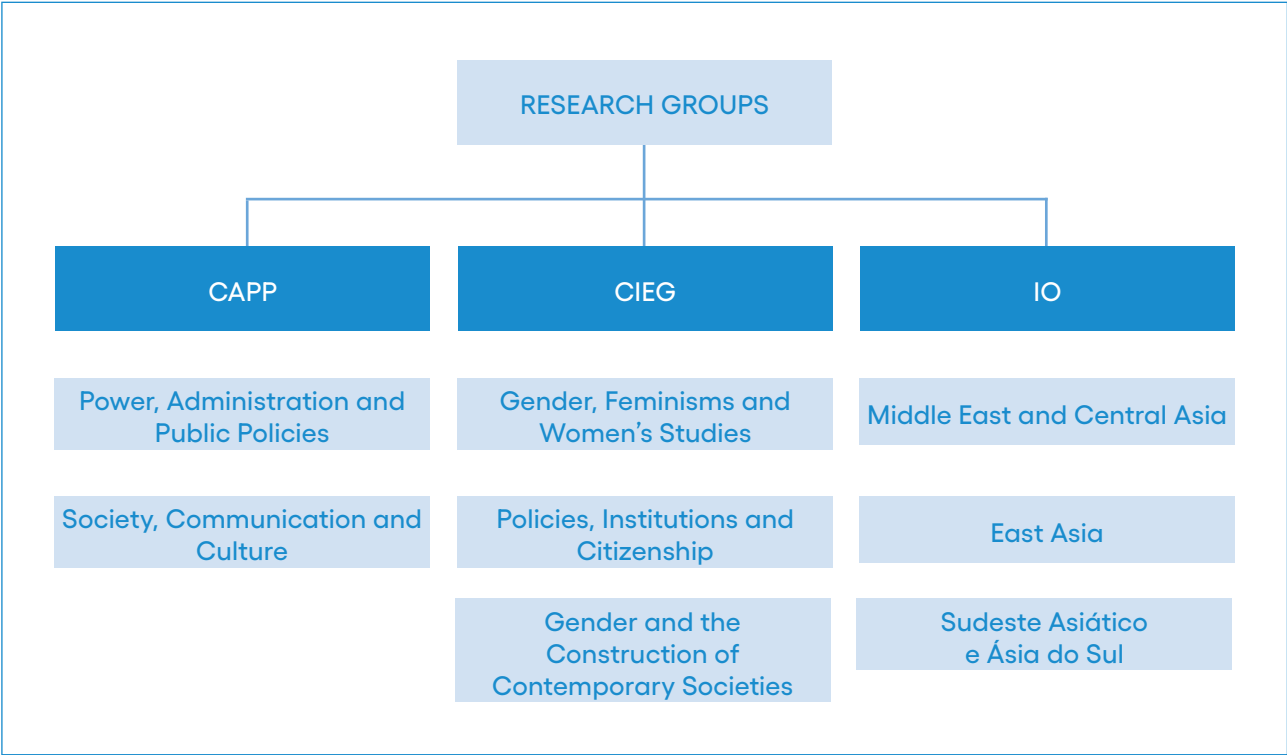

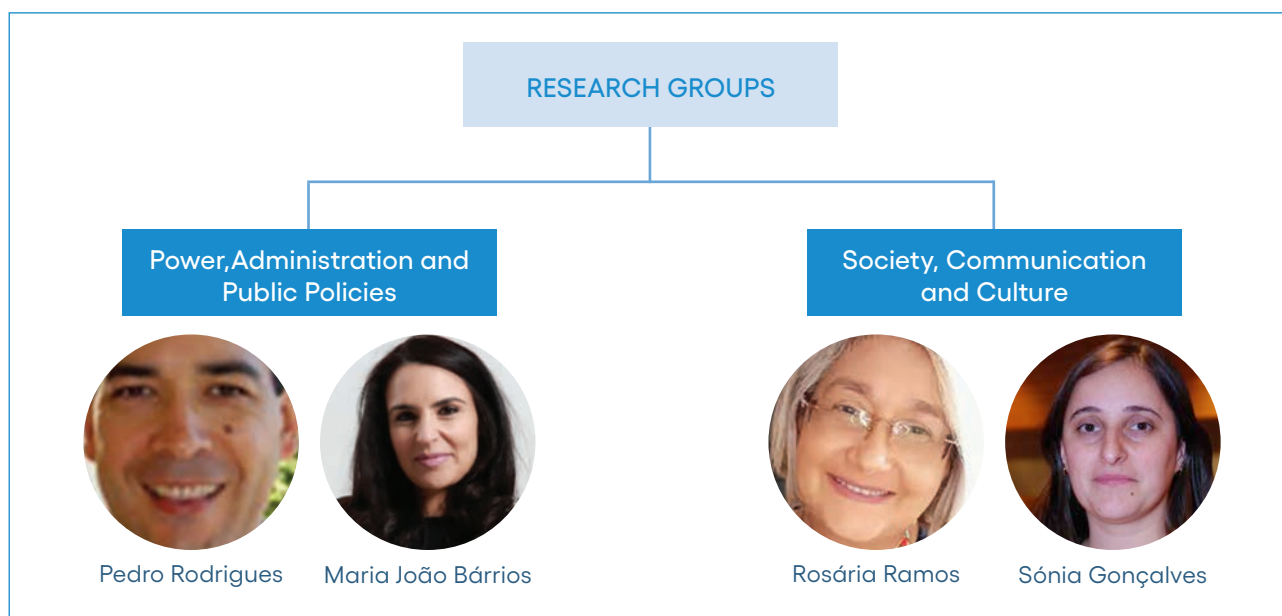
6.1 Centre for Administration and Public Policies

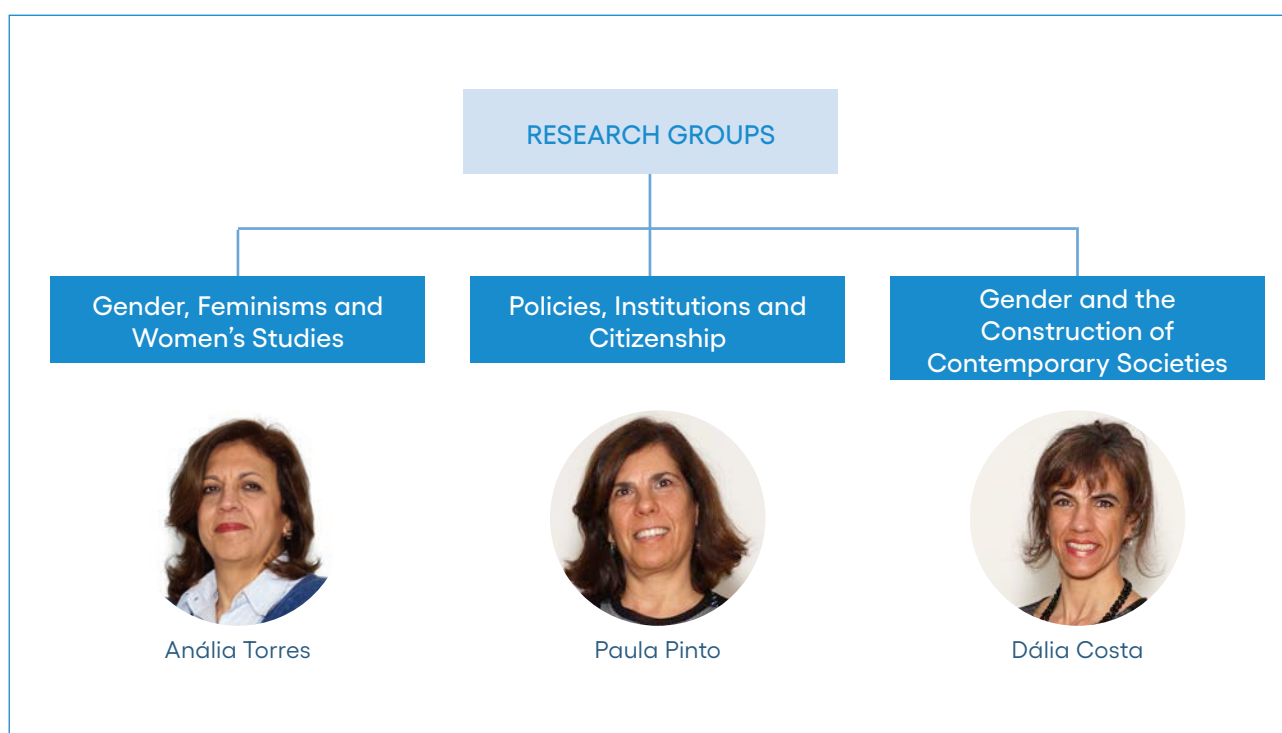


6.2 Interdisciplinary Centre for Gender Studies

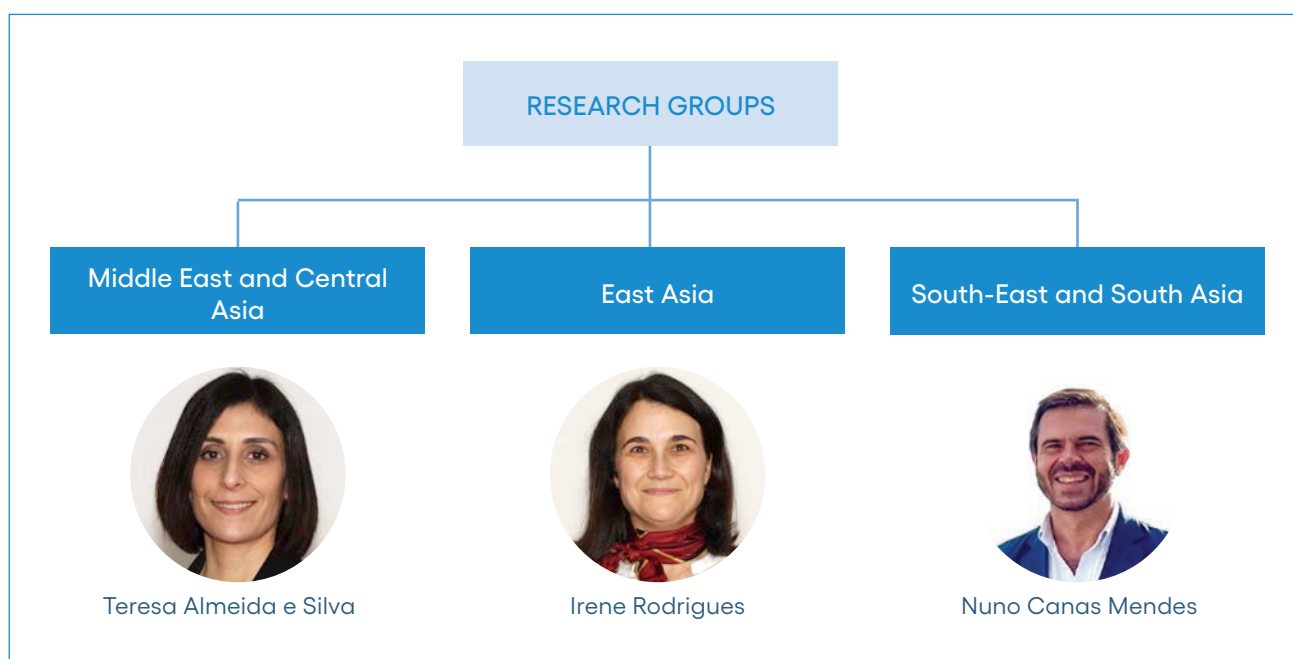
6.3 Orient Institute

The Orient Institute was created in 1989 in ISCSP-ULisboa, by decree no. 300/89 of 20 April, with the mission of “studying the history of the present-day Orient, specifically the Portuguese presence and its future”, namely in the Pacific area.

This is the oldest and most experienced research unit dedicated to Asian Studies in Portugal.

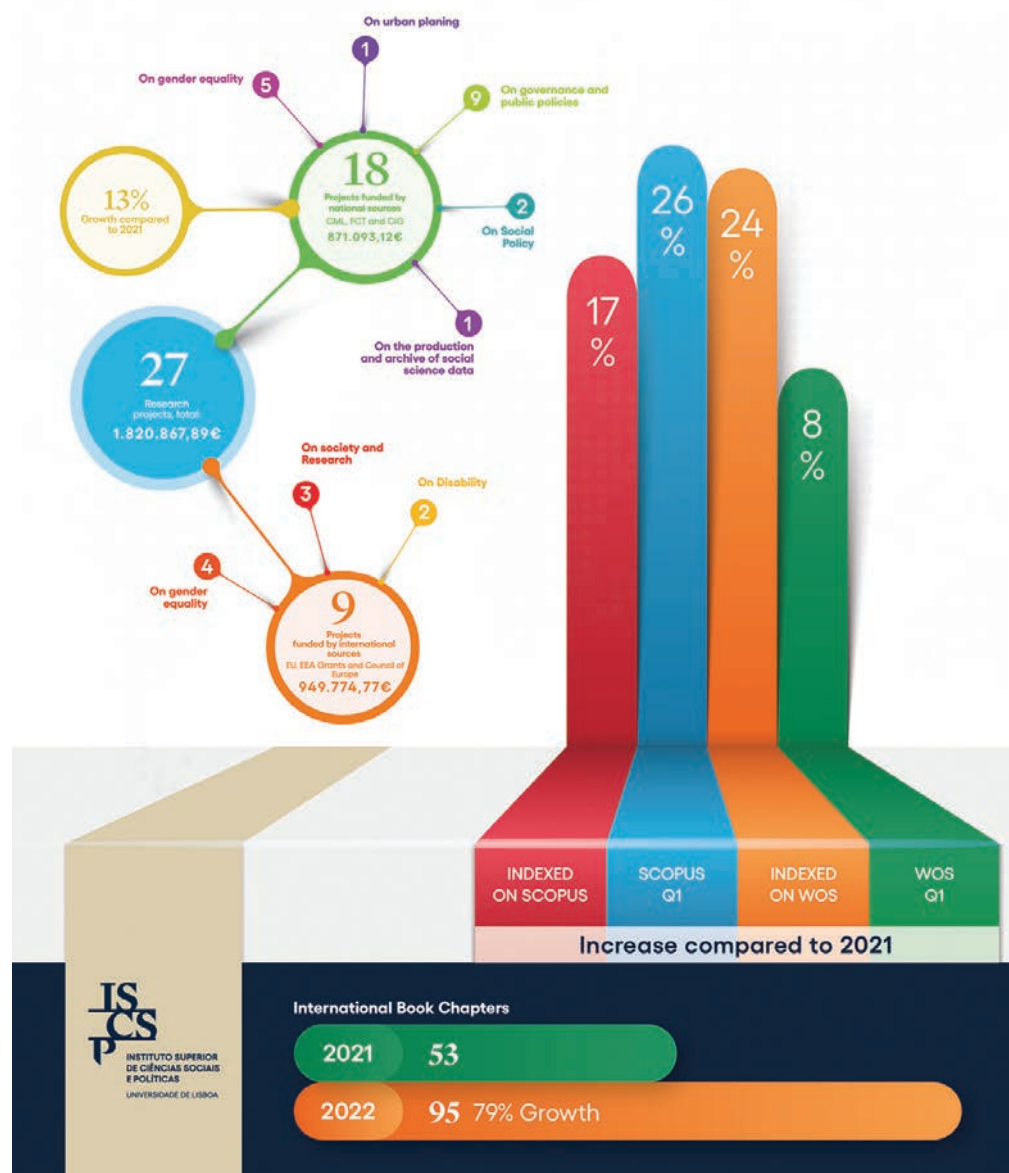
The specific realities of each sub-region and country are particularly relevant, as well as the relations between Portugal and Asia.

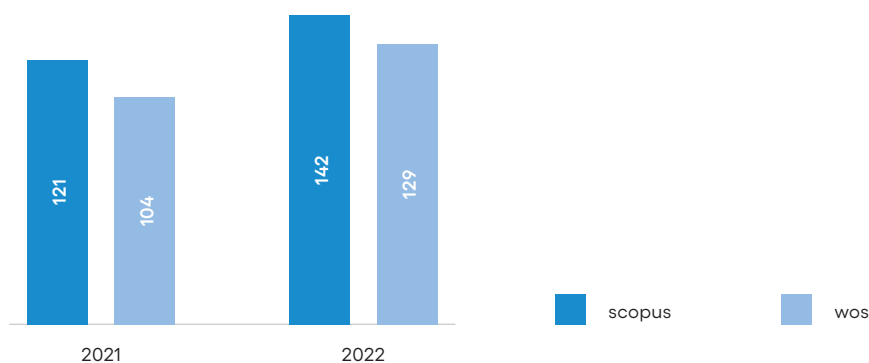

As the pandemic situation slowed down in 2022, we see a continuation of growth within the majority of indicators, with emphasis on a considerable increase in the number of international book chapters.

7.2 Scientific Articles

The number of scientific articles published in international journals indexed in SCOPUS and Web of Science (WoS) recorded an increase of 17% and 24% respectively, compared to 2021.

In the case of SCOPUS publications, there was a 26% increase in Q1 articles. WoS publications grew 8% in Q1 articles.



7.3 Presentations in Scientific Events

There was a 79% increase in the number of papers presented at national scientific meetings, and a reduction of just 5% at international scientific meetings, reflecting the gradual resumption of scientific activities in a post-pandemic context.

Between 2021 and 2022, the total number of ongoing research projects (27) registered a slight increase. Projects funded by national institutions increased by 13%.

50 Years of Democracy in Portugal

This project aims to assess the perceptions of the Portuguese population regarding to the functioning of the democratic regime, 50 years after the fall of the dictatorship in Portugal. A large survey will be carried out at national level to achieve this goal.

Annual Questionnaire and report on the monitoring of the Saint-Denis Convention (n.º 218)

The project aims to apply an annual questionnaire, which will lead to a report, with the goal of monitoring the implementation of the Saint-Denis Convention. The Saint-Denis Convention is an integrated approach to safety, security and services at sports events, promoted by the Council of Europe.

Evaluation of the Public Policy for Restorative Justice in Portugal

This project aims to analyse public policies for restorative justice in Portugal and seeks to answer the following questions: what are the reasons for the low uptake of restorative justice practices in Portugal? What is the nature of the public problem in question? Faced with the problem, how should public policy be formulated to ensure its proper implementation?

CRICITY – Children and their right to the city: tackling urban inequality through participatory design of child-friendly cities

This project aims to tackle this inequality through a participatory approach, by conducting research on the interactions between children and urban public spaces in the two main Portuguese cities (Lisbon and Porto), which are also two important tourist hotspots.

Diagnostic Study of the situation of Prostitution in the City of Lisbon

The aim of this project is to carry out a diagnosis of the situation of prostitution in the city of Lisbon, through the collection and systematisation of relevant

information which will provide a basis for the Lisbon City Council's intervention strategy in the area of prostitution.

HealME - Ranking priorities for Digital Health in Portugal: How Aligned Are Health Managers' Perceptions with Official Policy Perspectives?

This project aims to assess the perception of health managers regarding their priorities for digital health in Portugal and their alignment with public policies in this field. The project aims to create a toolkit on digital health policies in Portugal, identifying convergences and divergences between different actors.

Indexes of Good Governance and Socio-Territorial Cohesion in Metropolitan Areas and Regions (MA/MR) in Portugal and Brazil: The case of the MA of Lisbon (Portugal) and the MRs of Cariri and Fortaleza (Brazil)

This research mainly aims to develop an assessment instrument for metropolitan governance and social cohesion, based on the Brazilian (Cariri and Fortaleza) and Portuguese (Lisbon) metropolitan administration models, in order to establish indicators of good governance, focusing on the role of reinforcing socio-territorial cohesion in the research MA/MR.

LIFE LUNGS II- Towards a more Resilient Lisbon Urban Green Infrastructure as an Adaptation to Climate Change

This project aims to contribute to the Municipal Strategy for Adaptation to Climate Change (EMAAC, 2017), by promoting the city's resilience to temperature increase and water scarcity. This project is implemented by the Lisbon Municipality (CML) with funding from the European Commission – LIFE Climate Action in partnership with the Ayuntamiento de Málaga (Spain). The LIFE LUNGS project aims to establish Lisbon as a sustainable city.

Telework in the context of digital transformation: An integrative perspective of the past, present, future, and stakeholders

This project has the general goal of providing an integrated view of telework in the pre-pandemic past, in the pandemic at a time of widespread confinement, in the current present and also in the future, with the compilation of results in different outputs, safeguarding specificities and singularities, potentially emerging, from the corporate context and public administration.

Planning the Future of Research & Innovation in the European University Alliance UNITE!

Unite! is an Alliance of European Universities that aims to continue the creation of a European Higher Education Area that is able, through a new generation of Europeans, committed to transnational, transdisciplinary and multilingual co-

operation, to face great societal challenges, contributing to asserting Europe's leadership as a knowledge space.

Public policies to encourage business creation and entrepreneurship in Portuguese municipalities

This project aims to understand the impact of best practices incentivizing business creation and entrepreneurship in both national and international levels. It also aims to understand the effect that local public policies have on business creation in municipalities.

Public Fiscal Governance in the Post Covid-19 and Digital Era

This project aims to modernize Public Fiscal Governance, in the wake of post-pandemic structural changes, associating a global strategic vision of different public finance themes with more specific aspects, with special attention to fiscal policies.

WideGAMA - Worldwide Government Accountability Map

This project intends to carry out a survey of the dimensions of accountability and institutional arrangements within the scope of external government control, in order to build a matrix of profiles, using the cluster technique, and will seek to understand which dimensions and variables most relate to each other and are associated with transparency, accountability and the perception of corruption in Public Administrations.

PASSDA - Production and Archive of Social Science Data

This project represents Portuguese infrastructure for collecting, archiving and disseminating data on attitudes, values and socio-political behaviour. It is the Portuguese hub for several international research networks that collect this type of data by the means of surveys and representative samples of the population, such as the European Social Survey-ERIC, the Comparative Study of Electoral Systems, and network of database archives CESSDA-ERIC.

ALLINTERACT - Widening and Diversifying Citizen Engagement in Science

The general objective of the project is twofold: on the one hand, it aims to the creation of new knowledge to transform the potential participation of citizens in science, effectively committing to scientific research; on the other hand, it aims to searching for new ways of engaging social actors, including citizens and groups that are traditionally excluded from science.

Study on Bullying and Sexual Harassment of Lisbon Municipal Workers

This project, funded by the Lisbon City Council, aims to carry out a diagnostic study on bullying and sexual harassment in the labour market of the Lisbon City Council, consultancy for the design of instruments to prevent and combat the phenomena of bullying and sexual harassment, for the design of a network for reporting and referencing cases of bullying and sexual harassment, and for the drafting of a code of conduct, information and awareness-raising resources.

BO(U)NDS - Ties, Boundaries and Violence: A longitudinal study of school-based pro-programmes to prevent gender-based violence

BO(U)NDS aims to gain an in-depth understanding of what works in primary prevention regarding long-term effects in the lives of young people. We seek to understand the success and the obstacles in integrating non-violence values and gender equality in the lives of young people, resorting to focus groups and biographical narratives with young people who have attended gender violence prevention programs in school contexts, both in recent time and also over five years ago.

BOOMERANG - Study on perceptions of the economic impact of unequal sharing of unpaid work on the lives of immigrant women and men in Portugal

This research aims to characterise the perceptions of the economic impact of unpaid job sharing and divorce in the lives of immigrant women and men in Portugal, analysing its effects from the point of view of personal, family and professional reconciliation.

EDE – European Disability Expertise

The overall goal of this project is to collect, analyse and provide independent scientific data and information related to national disability policies and legislation and their relations with policy and legislation at EU level, as well as with the situations of people with disability.

EQUAL - Equality before the law and the right to self-determination of persons with intellectual and psychosocial disabilities in Portugal: An exploratory study

This project proposes to carry out an exploratory analysis of the challenges, barriers and opportunities that involve the implementation of Law 49/2018, the new legal framework that seeks to transpose into the national context the regulations of the United Nations Convention on the Rights of Persons with Disability (CRPD) relating to legal capacity and equality before the law.

GE-HEI - Gender Equality in Higher Education Institutions

This project aims to understand the factors of inequality in Higher Education, in relation to the low participation of women with advanced degrees in management positions in Higher Education institutions and in high profile positions in the academic career, identifying and combating these inequalities through the elaboration of a set of recommendations for the development of GE criteria in HEIs.

Social | Haters - Hate speech during COVID-19: prevalence, dynamics and patterns among young people

This project aims to contribute towards a better knowledge of expressions of hate among and by young people in social media in Europe. The project responds to the need to understand the prevalence of this phenomenon in the current youth context and to deepen the understanding regarding the impact, dynamics and patterns underlying their occurrence before and during COVID-19. The results of this project will contribute to a reflection on preventing and combating online hate speech among and by young people in Europe.

W@ARCH.PT - Women architects in Portugal: building visibility, 1942-1986

The presence of Portuguese women architects in architecture development, research and teaching is far from being outlined. The fundamental questions are: who, when and how have female architects contributed to our architectural history, albeit almost always in the shadows. The chronological framework begins in 1942, when Maria José Estanco was the first woman graduating in architecture in Portugal, and it ends in 1986, which was a crucial year in Portuguese history.

DARE – Disability Advocacy and Research for Europe

This project aims to train a new generation of researchers in the field of disability rights, integrating them in the main Universities with relevant work in this field, with exposure to the main civil society organisations working to guarantee the rights of people with disabilities.

Colourful Children – Promote Gender Equality at Preschool Education Level

This project aims to promote gender equality in pre-school education, resorting to activities on gender equality in kindergartens, with the objective of listing a set of good practices whose adoption will be suggested to the educational authorities of the participating countries (Portugal, Spain, Italy and Sweden). Together with the production of didactic contents, the project also focuses on training pre-school teachers.

ENIND and PAPCTSH Monitoring and Evaluation Project (2018-2021)

This project aims to monitor and assess the conditions, difficulties and needs felt in the implementation of policies concerning equality between women and men, tackling and preventing violence against women and domestic violence, discrimination on grounds of sexual orientation, gender identity and expression and sexual characteristics and combating and preventing trafficking in human beings in the last four years. This evaluation will imply an in-depth and rigorous examination that will allow a fine analysis of the implementation of the measures, the fulfilment of the foreseen goals and the possibilities of improvement and adjustment for the next political cycle.

FREE CHOICES - Stereotypes are not my gender: vocational and professional choices free of prejudice

This project's main objective is to create and implement a program to prevent gender stereotypes and promote gender equality, focused on vocational and professional choices, with young people from the 3rd cycle onwards in schools in the districts of Porto and Setúbal. Additionally, the project will contribute to the awareness of other young people, and to the scientific knowledge and training of professionals in this area.

8.2 Consultancy Projects

ISCSP-Ulissboa, through ISCSP-IFOR, has developed consultancy projects with multiple entities. In 2022, ISCSP's researchers developed the projects We are Mozambique II, Study of Anticipation of Qualification Needs in the Western Region, the Strategic Educational Plan for the Intermunicipal Development of the West and of the Municipal Educational Charters, the Definition of the Smart Region Governance Model, and the Social Network Evaluation System 2021.

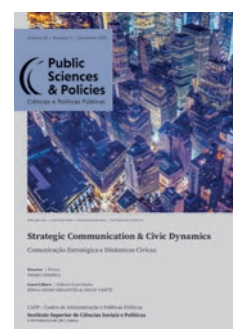

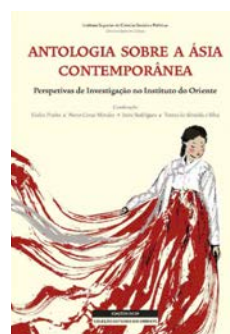

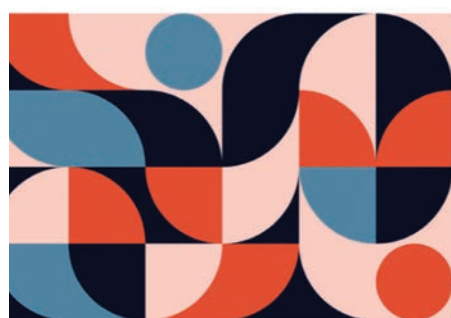

Political Observatory

The Political Observatory (OP) continued to update and renew ResPública, a system donated to the Political Observatory, which renamed it as POLITIPÉDIA - Portuguese Repertory of Political Science. This database is the most exhaustive collection of information, covering around 8,000 entries in the field of Political Science and more than 12,000 files. Given its importance, the OP carried out the updating and computer design, processing of the information and subsequent dissemination of results, constituting an important strategic action plan that is constantly being updated.

Observatory and Competence Centre in Restorative Justice

During 2022, the OCCJR promoted the dissemination of Restorative Justice in Portugal, namely through the research project Evaluation of the public policy of restorative justice in Portugal.

The Observatory's activities also took the form of publications by its members on the subject, as well as participation in national and international conferences, including the 11th Conference of the European Forum for Restorative Justice, entitled Restorative language beyond borders, which discussed the application of restorative justice in the Portuguese juvenile justice system. The OCCJR also applied to host the 12th International Conference of the European Forum for Restorative Justice at ISCSP-ULisboa.

Border and Migration Research Network

In 2022, RIFREM took part in the application submitted to the European CERV Programme (Citizens, Equality, Rights and Values Programme), entitled “NESTOR - miNd thE whiSTle fOr migrants”.

Social Impact of Research

Activities of the ODDH Advisory Board

Promotion of a network of 20 organisations active in the field of disability and researchers working on this issue. It also includes the University of Algarve and the University of Minho, as well as the Centre for Social Studies at the University of Coimbra, and the University of Porto.

Research on Sexual Harassment and Bullying in the Workplace in Portugal

This CIEG/ISCSP-ULisboa project continued to be one of the most used scientific supports in the media's approaches to this high-profile issue during 2022. Several CIEG researchers also took part in prime-time television programmes and large-circulation publications in this field.

GE-HEI - Gender Equality in Higher Education Institutions

This project is an extremely important contribution to public policy recommendations in the area of Gender Equality in Higher Education Institutions. The project was responsible for the inclusion of Gender Equality in the documents of the Higher Education Assessment and Accreditation Agency (one of the project's partners), and also for the creation of an award for the promotion of Gender Equality in HEIs, awarded by the Ministry of Science and Technology and Higher Education (to come into force in 2023).

Quality and Innovation working group

Researchers from CAPP/ISCSP-ULisboa took part in the General Quality Assurance Council of the University of Lisbon and co-ordinated a "Quality and Innovation" working group, as part of the activities of the Distance Education Section of the Portuguese Society of Educational Science.

Home Ownership from an Intergenerational Perspective

The project received countless mentions in various newspaper articles and contributed to the inclusion of housing in the Intergenerational Justice Index - an innovative study developed by the Institute of Public Policy (IPP), in which several authors from different universities collaborate. Funded by the Calouste Gulbenkian Foundation, it aims to evaluate public policies and contribute to the well-being of younger generations.

Participation in the IDN Brief

Publication of opinion articles on current security and defence issues, at the invitation of the National Defence Institute. In 2022, the articles “What Can the United Nations Do for Ukraine” and “Ocean Governance and National Defence” were published.

Project Older Portugal - Training those who care, sensitising those who decide

Consultancy and participation in the project’s Advisory Committee, promoted by the Portuguese Association for Victim Support (APAV) in partnership with the Calouste Gulbenkian Foundation. The aim of the project is to equip trainees with the ability to identify, intervene and prevent the risk factors of violence in their role as carers of older people; to understand violence against older people and the provision of professional care; the risk factors and protective factors in violence against older people.

Qual’Idade Project

Participation and Consultancy on the Advisory Board of this project, run by the Aga Khan Foundation Portugal, which aims to combat social and demographic isolation, promote civic participation and promote active and healthy ageing.

Project “BOOMERANG - Study on the perceptions of the impact of the unequal sharing of unpaid labour by immigrant women and men”

Given the geopolitical changes and consequent migratory crises, in 2022 this project acquired a visibility of the utmost relevance in the current political and social context.

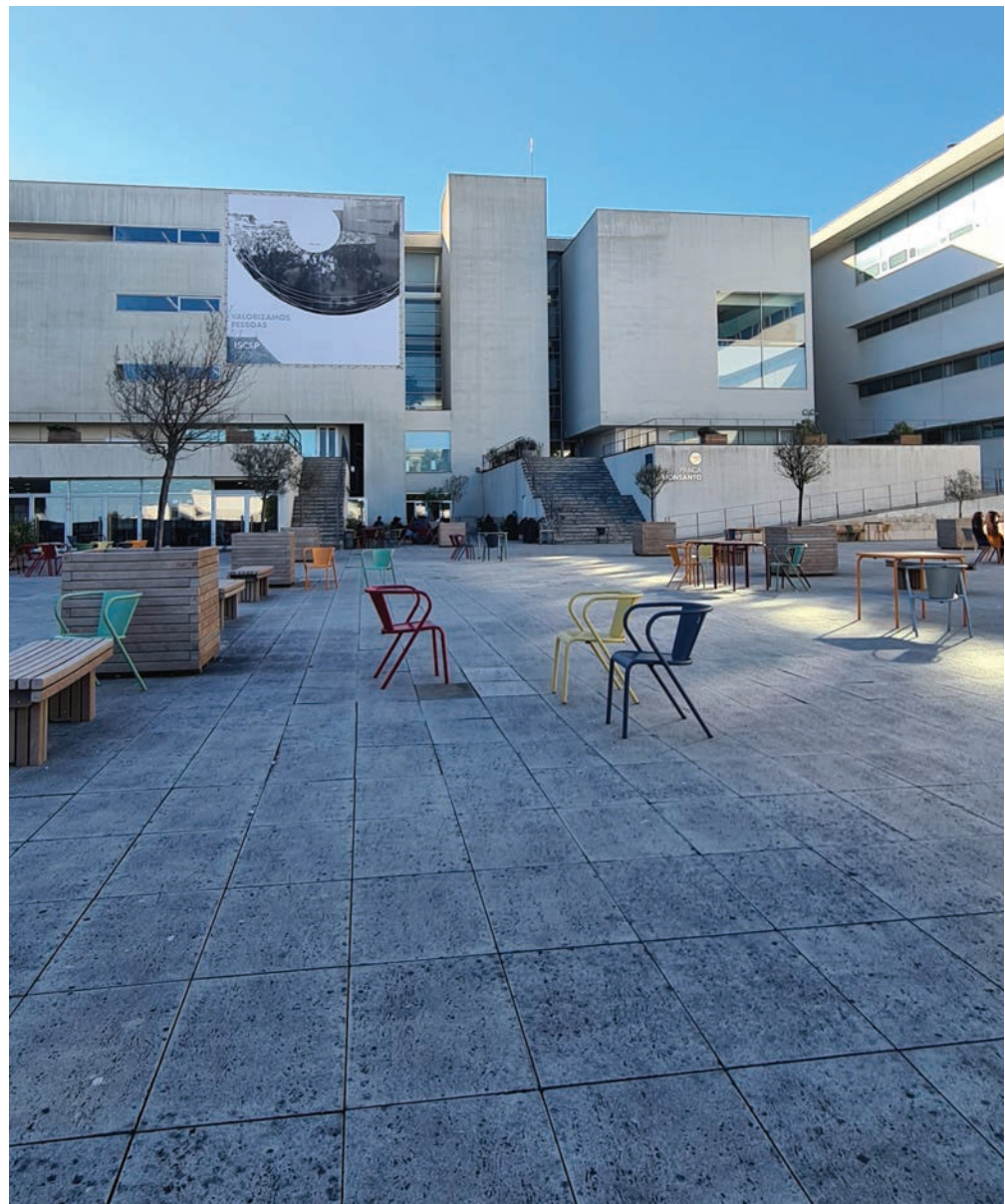
Semester at Sea

Organisation of a face-to-face session as part of the Semester at Sea initiative (Institute for Shipboard Education, USA), at ISCSP-ULisboa. The aim of the session was to present CIEG and its main activities to a group of international students in the pre-university education phase. In addition to diversifying the target audience,

this initiative is also a contribution to the internationalisation of the Centre and the Institute.

Parallel Report on the 10th Periodic Report submitted by Portugal under Article 18 of the Convention on the Elimination of All Forms of Discrimination against Women

This ‘Parallel Report’, signed by 13 entities representing approximately 186 organisations in the field of disability and by 7 researchers working in the field of disability and human rights, thus constituting a response to the European Disability Forum’s call for the participation of civil society in the monitoring process of the Convention on the Elimination of All Forms of Discrimination against Women.

Sustainability

Research data suggests a growing importance in the field of sustainability. ISCSP's research activities are aligned with the Sustainable Development Goals (SDGs), covering the different scientific areas in which the Institute operates.

Scientific publications

Publication in indexed scientific journals, in particular the journal Sustainability, and also in books by leading publishers, as part of handbooks or compilations of chapters in which researchers of recognised scientific merit at national and international level participate frequently. We highlight Springer, with its collection on the SDGs, as the publisher of reference. Part of this scientific work has also been the dissemination of knowledge through participation in conferences, congresses and seminars, where the researchers have disseminated the results of their research. Our researchers have tackled topics such as citizenship, climate change, cities and public policies.

Teaching-research synergies

In direct relation to ISCSP-ULisboa's teaching areas, we would highlight the activity in the area of Public Administration, particularly in terms of the sustainability of tax and financial systems, namely addressing the fight against tax evasion as a means of maintaining the sustainability of national financial systems; in the area of Human Resources Management, where research has been carried out into organisations and employee satisfaction, particularly with regard to the conciliation between professional, personal and family life, but also with regard to organisations' social responsibility practices and environmental policies and the positive effect their presence has on employee motivation; Social Work and Social Policy, which have recently been tackling sustainable social intervention and collective responsibility, as well as demographic sustainability and migration. In the area of Sociology, the sustainability of urban and public spaces has been the main focus, with a special emphasis on green spaces; research into public diplomacy; sustainability and ethics also stands out in the area of Communication Sciences.

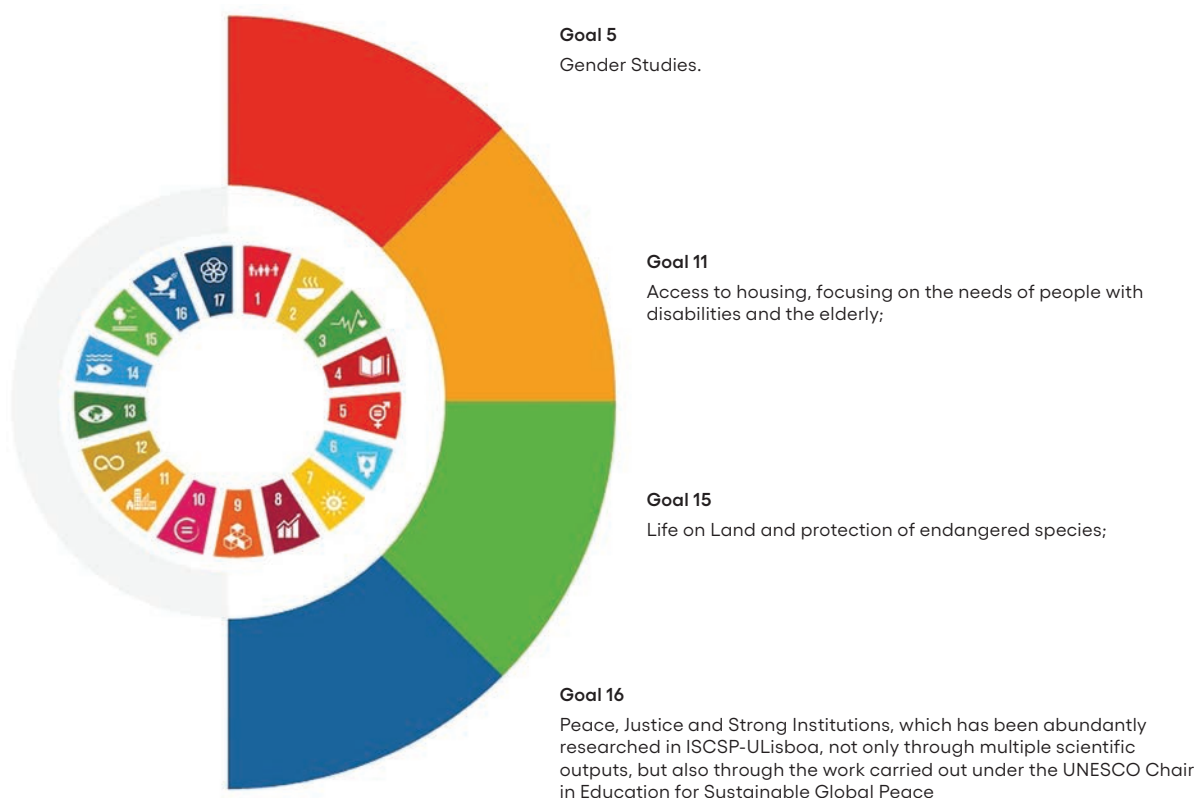
Networks

The presence of several researchers in networks, such as the Sustainable Welfare & Eco-social Policy Network, commissions and working groups with sustainability goals, is also particularly in relation to social security and welfare systems, and corporate responsibility, is also noteworthy.

Cross-cutting connection to the SDGs

Projects, publications and dissemination actions have also been developed, in direct response to several Sustainable Development Goals, namely in terms of Gender Studies (Goal 5) and Goals related to the Environment and ecological issues. We would also highlight Goal 16 (Peace, Justice and Effective Institutions), which has been worked on extensively at ISCSP-ULisboa, not only through multiple scientific outputs, but also through the work carried out under the UNESCO Chair in Education for Sustainable Global Peace.

A cross-cutting theme is also evident, reflecting more recent concerns of pressing importance in the wake of the COVID-19 pandemic, namely with regard to the sustainability and reorganisation of health services, and distance relationships, particularly with regard to specific dynamics in education and work.
