PUBLIC NOTICE FOR THE ATTRIBUTION OF A RESEARCH GRANT (BI), FOR A MASTER'S DEGREE HOLDER, UNDER THE PROJECT "50 ANOS DE DEMOCRACIA EM PORTUGAL: ASPIRAÇÕES E PRÁTICAS DEMOCRÁTICAS", TO BE DEVELOPED IN THE CENTRE FOR PUBLIC ADMINISTRATION AND PUBLIC POLICIES (CAPP) OF THE INSTITUTE FOR SOCIAL AND POLITICAL SCIENCES OF THE UNIVERSITY OF LISBON (ISCSP-ULISBOA)

It is available an application for the attribution of one (1) Research Grant (BI), for a master's degree holder, from February 12th to February 23rd of 2024, under the project "50 anos de democracia em Portugal: Aspirações e práticas democráticas", UIDB/00713/2020, to be developed in the Centre for Public Administration and Public Policies (CAPP) of the Institute for Social and Political Sciences of the University of Lisbon (ISCSP-ULisboa).

Scientific Area:

Political Science.

Admission requirements (cumulative):

- Master's Degree in Political Science;
- Frequency of a PhD in Political Science;
- Publications and scientific communications on the political participation of young people, especially on the Portuguese case.

Working plan:

- Collaborate in the development of the CAPP of ISCSP-ULisboa research project, "50 years of democracy in Portugal: aspirations and democratic practices";
- Deepen skills in the area of quantitative data analysis with SPSS and R for the purposes of processing and analysing project data;
- Collaborate in the planning and execution of outputs of the project in question, namely conferences and publications;
- Plan and execute digital content for disseminating the project and its results;
- Production of project reports in reference;
- Collaborate in the execution of internal teaching/research, resulting from the project;
- Development of the PhD final thesis in Political Science on the political participation of young people.

Workplace:

The activities will be developed in CAPP of ISCSP-ULisboa, under the scientific supervision of Professor Maria da Conceição Pequito Teixeira and Professor Pedro Miguel Moreira de Fonseca.

Grant duration:

The grant will last until December 31st 2024, expected to start on April 1st of 2024, and may be renewed under the terms foreseen in Regulation of Research Grants of FCT an University of Lisbon. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

Monthly Maintenance Allowance:

The amount of the monthly maintenance allowance corresponds to € 1 199.64, according to the current table of values of grants awarded directly by FCT, I.P. (www.fct.pt/apoios/bolsas/valores). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law n.º 40/89, of February 1st, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

Selection Methods:

Applicants will be ranked on a scale from 0 to 100 values.

The selection of candidates will be based on the Curricular Evaluation (50%) and the Interview (50%).

1. The curricular evaluation will be weighed as follows:

- a) Advanced Knowledge in terms of management and development or research projects in the Political Science area (20%);
- b) Experience in activities in research units (5%);

- c) Publications and scientific communications on the political participation of young people, especially on the Portuguese case (20%);
 - d) Knowledge of statistics for social sciences, and quantitative/qualitative data analysis in Political Science (5%).
2. The interview will be weighed as follows:
- a) Adequacy of the profile (25%);
 - b) Motivation and experience to participate in organization activities and execute research projects (25%).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, gender image or identity, sexual orientation, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, religion, political or ideological convictions and union trade membership.

Notification Process of Results:

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP-ULisboa. The approved candidate will be notified by email.

Application date:

The application is available from February 12th to February 23rd of 2024.

Application presentation:

The applications must be formalized, mandatorily, accompanied by the following documents:

- a) Application letter with the identification of the candidate and procedure to which it relates;
- b) Documents proving that the candidate meets the admission requirements, namely a copy of the qualification certificate of the Bachelor's and Master's degree, with final average obtained;
- c) Detailed *Curriculum Vitae*;
- d) Document proving enrolment in the PhD's degree;
- e) Declaration under oath that there is no professional or service provision activity that violates the duty of exclusive dedication;
- f) Copy of the civil identification document and, whenever applicable, copy of the proof of residence permit or other legally equivalent document;
- g) Motivation letter;
- h) Documents proving compliance with admission requirements;
- i) Other supporting documents considered relevant for the application process.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of August 16th, and Ordinance n.º 33/2019, of January 25th.
