It is available an application for the attribution of one (1) Post-Doctoral Research Grant (BIPD), for a doctor's degree holder, from May 23<sup>rd</sup> to June 6<sup>th</sup> of 2024, under the R&D Unit UIDB/04018/2020, to be developed in the Orient Institute (IO) of the Institute for Social and Political Sciences of the University of Lisbon (ISCSP-ULisboa).

# **Scientific Area:**

Asian Studies.

#### Admission requirements (cumulative):

- PhD degree in any area of Social Sciences, obtained in the three years prior to the date of submission of the application;

- Have at least 2 (two) publications in the field of Asian Studies, namely in the domains developed by the research groups of Orient Institute;

- Proven experience in research in the field of Asian Studies;
- Proven experience of pre-doctoral scientific work;
- Proven knowledge of English.

#### Working plan:

- Develop an original post-doctoral research project in the field of Asian Studies, duly framed within one of the research groups of the Orient Institute;

- Present communications at national and international scientific events;
- Publish the results of the research in digital format.

#### Workplace:

The activities will be developed in IO of ISCSP-ULisboa, under the scientific supervision of Professor Nuno Gonçalo de Carvalho Canas Mendes.

#### **Grant duration:**

The grant will last until December  $31^{st}$  of 2024, expected to start on July  $1^{st}$  of 2024, and may be renewed under the terms foreseen in Regulation of Research Grants of FCT an University of Lisbon. The maximum duration of the contract to be established between ISCSP-ULisboa and the selected applicant is entirely linked to the duration of the project being on its basis, not exceeding its duration.

#### **Monthly Maintenance Allowance:**

The amount of the monthly maintenance allowance corresponds to  $\in$  1 801.00, according to the current table of values of grants awarded directly by FCT, I.P. (<u>www.fct.pt/apoios/bolsas/valores</u>). To the value of the monthly subsidy is added the payment of the charges resulting from the contributions that fall on the first of the steps referred to in article 36 of Decree-Law n<sup>o</sup> 40/89, of February 1<sup>st</sup>, regarding the Voluntary Social Insurance, whose adhesion is the responsibility of the fellow.

#### **Selection Methods:**

Applicants will be ranked on a scale from 0 to 100 values.

The selection of candidates will be based on the Curricular Evaluation (30%), Activity Plan (20%) and the Interview (50%).

- 1. The <u>curricular evaluation</u> will be weighed as follows:
  - a) Academic pathway (15%);
  - b) Proven experience of pre-doctoral scientific work (10%);
  - c) Curriculum Vitae assessment (5%).
- 2. The <u>activity plan</u> will be weighed as follows:
  - a) Development of an original post-doctoral research project in the field of Asian Studies, in accordance with one of the research groups of Orient Institute (15%);
  - b) Presentation of communications at national and international scientific events (5%).
- 3. The <u>interview</u> will be weighed as follows:
- a) Ability to communicate orally and written in English (10%);



- b) Adequacy of the candidate's profile to the work plan to be developed (15%);
- c) Defence of the proposed research plan (25%).

No candidate should be privileged, benefited, impaired, or deprived of any right or exempted of any duty on the basis of, namely, ancestry, age, gender image or identity, sexual orientation, marital status, family situation, economic situation, education, origin or social condition, genetic heritage, reduced working capacity, disability, chronic disease, nationality, ethnic origin or race, place of origin, religion, political or ideological convictions and union trade membership.

#### **Notification Process of Results:**

The final results of the evaluation will be publicized on an alphabetically ordered list, posted in a visible and public place of ISCSP-ULisboa. The approved candidate will be notified by email.

## Application date:

The application is available from May 23<sup>rd</sup> to June 6<sup>th</sup> of 2024.

## Application presentation:

The applications must be formalized, mandatorily, accompanied by the following documents:

- a) Application letter with the identification of the candidate and procedure to which it relates;
- b) Documents proving that the candidate meets the admission requirements, namely a copy of the qualification certificate of the Bachelor's, Master's and PhD degree;
- c) Activities plan for post-doctoral research in the field of Asian Studies;
- d) Detailed Curriculum Vitae;
- e) Declaration under oath that there is no professional or service provision activity that violates the duty of exclusive dedication;
- f) Copy of the civil identification document and, whenever applicable, copy of the proof of residence permit or other legally equivalent document;
- g) Motivation letter;
- h) Other supporting documents considered relevant for the application process.

Academic degrees obtained in foreign countries require registration by a Portuguese Institution, in accordance with Decree-Law n.º 66/2018, of August 16<sup>th</sup>, and Ordinance n.º 33/2019, of January 25<sup>th</sup>. <u>The presentation of the certificate is mandatory for the signing of the contract</u>.
